Fireworks Ordinance Update

Fire Marshal Joe Wheeling was present to discuss the update of the City's Fireworks Ordinance. He stated the National Fire Prevention Association (NFPA) had guidelines that he followed with regard to the sale and discharge of fireworks, along

with the City's fireworks ordinance. He stated he was using the 2006 NFPA Regulations.

Fire Marshal Wheeling explained the NFPA recently adopted the 2018 Regulations, which had taken the Fireworks Regulations (Chapter 7) out and there were no other regulations with regard to fireworks. He reported since he had been using these regulations along with the City's ordinance, this was the way he had authority to shut down illegal or dangerous fireworks stands.

Fire Marshal Wheeling requested the City review and adopt the draft ordinance to bolster the authority of the Fire Marshal/Department to ensure the safety of fireworks stands for the citizens purchasing fireworks.

Mayor Burtner noted the ordinance was not up for a vote at this time to give the Commission time to review the document.
